7 **A Resolution approving the unclassified position and salary schedule of Director of Victim**
8 **Services #27028 to be added to the County Prosecutor's unclassified salary schedule and**
9 **removal of the Director of Victim Services from the classified plan, for the Executive's**
10 **Department of Human Resources and the Prosecutor, and declaring an emergency.**

12 WHEREAS, County Council has the authority pursuant to Article III, Section 3.03 (10)
13 of the Charter of the County of Summit and Sections 169.08, 169.09, 169.10 and 169.11 of the
14 Codified Ordinances of the County of Summit, to establish classifications, classification
15 specifications and pay/salary schedules for all County employees; and

16
17 WHEREAS, the County Prosecutor requests that the position and salary schedule for the
18 exempt unclassified position of Director of Victim Services #27028 at the County Prosecutor's
19 Office be approved by this Council because the current position of Director of Victim Services is
20 designated as classified, which is not proper for a position with fiduciary responsibilities to an
21 Appointing Authority; and

23 WHEREAS, the County Prosecutor requests that the classification Director of Victim
24 Services be removed from the classified plan; and

26 WHEREAS, at its March 20, 2014 meeting, the County Human Resource Commission
27 ("HRC") approved the change in designation to exempt unclassified for the aforementioned
28 position at the County Prosecutor's Office and issued HRC Order 14-01 stating the same, which
29 is attached hereto as Exhibit C and incorporated herein as if fully restated; and

31 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
32 that it is necessary and in the best interest of the County of Summit to adopt the position and
33 salary schedule for the exempt unclassified position of Director of Victim Services #27028 at the
34 County Prosecutor's Office;

36 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
37 of Ohio, that:

41 The position and salary schedule for Director of Victim Services #27028 at the County
42 Prosecutor's Office is hereby approved, designated as exempt unclassified and assigned the
43 salary schedule set forth in Exhibit A, which is attached hereto and incorporated herein as if fully
44 restated.

48 The classification specification for the exempt unclassified position of Director of Victim
49 Services #27028 at the County Prosecutor's Office, which is attached hereto as Exhibit B and
50 incorporated herein as if fully restated, is hereby approved.

10 using the position.

15 effect immediately upon its adoption and approval by the Executive; otherwise it shall take effect
16 and be in force at the earliest time provided by law.


