7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Inspiron Logistics for a one-year service agreement for the Wireless**
9 **Emergency Notification System, for public safety agencies throughout Summit County,**
10 **with three options to renew for a one-year period, as Best Practical Source, in an amount**
11 **not to exceed \$46,950.00 per year, for the Executive's Department of Law, Insurance and**
12 **Risk Management – Division of Public Safety/Emergency Management Agency, and**
13 **declaring an emergency.**

15 WHEREAS, the Board of Control, at its meeting held April 16, 2014, awarded a
16 professional service contract with Inspiron Logistics for a one-year service agreement for the
17 Wireless Emergency Notification System, for public safety agencies throughout Summit County,
18 with three options to renew for a one-year period, as Best Practical Source, subject to
19 confirmation by County Council; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that the contract is necessary and in the best interest of the County of Summit;

24 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
25 of Ohio, that:

29 The award by the Board of Control of a professional service contract with Inspiron
30 Logistics for a one-year service agreement for the Wireless Emergency Notification System, for
31 public safety agencies throughout Summit County, with three options to renew for a one-year
32 period, as Best Practical Source, in an amount not to exceed \$46,950.00 per year, is hereby
33 confirmed and the County Executive is hereby authorized to execute such contract.

37 This Resolution is hereby declared an emergency in the interest of the health, safety and
38 welfare of the citizens of the County of Summit, and for the further reason to immediately
39 provide for service for public notification and warning in 2014.

43 Provided this Resolution receives the affirmative vote of eight members, it shall take
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
45 effect and be in force at the earliest time provided by law.
