7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with Thomson Reuters for online legal research services for 70 attorney and 70**
9 **non-attorney users, for the period 7/1/14 to 6/30/17, as Best Practical Source, in an amount**
10 **not to exceed \$125,651.27 for the three-year period, for the Prosecutor, and declaring an**
11 **emergency.**

13 WHEREAS, the Board of Control, at its meeting held May 7, 2014, awarded a
14 professional service contract with Thomson Reuters for online legal research services for 70
15 attorney and 70 non-attorney users, for the period 7/1/14 to 6/30/17, as Best Practical Source,
16 subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the contract is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

26 The award by the Board of Control of a professional service contract with Thomson
27 Reuters for online legal research services for 70 attorney and 70 non-attorney users, for the
28 period 7/1/14 to 6/30/17, as Best Practical Source, in an amount not to exceed \$125,651.27 for
29 the three-year period, is hereby confirmed and the County Executive is hereby authorized to
30 execute such contract.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further reason to immediately
36 provide for online legal research services effective 7/1/14.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.

46 It is found and determined that all formal actions of this Council concerning and relating
47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
48 deliberations of this Council and of any of its committees that resulted in such formal action,

50 121.22 of the Ohio Revised Code.


