7 **A Resolution authorizing the County Executive to execute an Ohio Public Works**
8 **Commission grant application and any other documents necessary to apply for and accept**
9 **Local Transportation Improvement Program grant funds, in the amount of \$344,350.00,**
10 **for the resurfacing of Olde Eight Road from Aurora Road (State Route 82) to Seiberling**
11 **Drive in Northfield Center Township and Sagamore Hills Township, in County Council**
12 **District 1, with no local cash match requirement, for the Engineer, and declaring an**
13 **emergency.**

14
15 WHEREAS, the County Engineer concludes that there is a public need for the resurfacing
16 of Olde Eight Road from Aurora Road (State Route 82) to Seiberling Drive in Northfield Center
17 Township and Sagamore Hills Township, in County Council District 1; and

18
19 WHEREAS, the County of Summit is eligible to acquire Ohio Public Works Commission
20 Local Transportation Improvement Program ("LTIP") grant funds, in the amount of \$344,350.00
21 for resurfacing of Olde Eight Road, with no amount necessary for local matching county road
22 and bridge funds; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that it is necessary and in the best interest of the County of Summit to authorize the County
26 Executive to execute an Ohio Public Works Commission grant application and the County
27 Engineer to execute any other documents necessary to accept and administer LTIP grant funds
28 for the aforementioned purpose;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that:

33 SECTION 1

34
35 The County Executive is authorized to execute an Ohio Public Works grant application
36 and the County Engineer to execute any other documents necessary to accept and administer a
37 grant for Ohio Public Works Commission Local Transportation Improvement Program ("LTIP")
38 funds, for the purpose of resurfacing of Olde Eight Road from Aurora Road (State Route 82) to
39 Seiberling Drive in Northfield Center Township and Sagamore Hills Township, in County
40 Council District 1 ("Project").

42 SECTION 2

44 The terms of said application shall request 100% of the cost of said project from the Ohio
45 Public Works Commission.

47 SECTION 3

49 The County Executive is authorized to execute said grant application necessary to apply
50 for the aforementioned grant funds only for the Ohio Public Works Program Year 29, with
51 further authorization required for any future grant applications for the purpose of resurfacing of
52 Olde Eight Road from Aurora Road (State Route 82) to Seiberling Drive.

12 This Resolution is hereby declared an emergency in the interest of the health, safety and
13 welfare of the citizens of the County of Summit, and for the further reason that it will allow the
14 County to obtain grant funds for an immediately needed resurfacing project in Council District 1.

18 Provided this Resolution receives the affirmative vote of eight members, it shall take
19 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
20 effect and be in force at the earliest time provided by law.

24 It is found and determined that all formal actions of this Council concerning and relating
25 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
26 deliberations of this Council and of any of its committees that resulted in such formal action,

28 121.22 of the Ohio Revised Code.
