7 **A Resolution, pursuant to Section 177.13 of the Codified Ordinances of the County of**
8 **Summit, ratifying purchases by the County Executive for the Department of**
9 **Environmental Services in calendar year 2014 from Great Lakes Pump Company, LLC,**
10 **for replacement parts for pump station operations, in the aggregate amount of \$52,065.70,**
11 **and authorizing additional purchases in an amount not to exceed \$47,934.30, for a total**
12 **aggregate amount not to exceed \$100,000.00, for calendar year 2014, for the Executive's**
13 **Department of Environmental Services, and declaring an emergency.**

15 WHEREAS, Section 177.13 of the Codified Ordinances of the County of Summit
16 requires that purchases by an officeholder exceeding \$25,000.00 in aggregate in any calendar
17 year, where no additional competitive quotes or bids have been taken, shall be made only upon
18 authorization of County Council; and

20 WHEREAS, the Department of Finance and Budget and the Board of Control have
21 previously approved purchases by the County Executive in calendar year 2014 in aggregate
22 totaling \$52,065.70 for the Department of Environmental Services with Great Lakes Pump
23 Company, LLC, for replacement parts for pump station operations; and

25 WHEREAS, the Executive's Department of Environmental Services anticipates that the
26 County Executive will make additional purchases in calendar year 2014 from Great Lakes Pump
27 Company, LLC, for replacement parts in an additional amount not to exceed \$47,934.30, for a
28 total aggregate amount not to exceed \$100,000.00 in calendar year 2014; and

30 WHEREAS this Council finds and determines, after reviewing all pertinent information,
31 that it is necessary and in the best interest of the County to ratify purchases by the County
32 Executive in calendar year 2014 from Great Lakes Pump Company, LLC, for replacement parts
33 for pump station operations in the aggregate amount of \$52,065.70, and to authorize additional
34 purchases in an amount not to exceed \$47,934.30, for a total aggregate amount not to exceed
35 \$100,000.00, for calendar year 2014.

37 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

42 This Council hereby ratifies purchases by the County Executive for the Department of
43 Environmental Services in calendar year 2014 from Great Lakes Pump Company, LLC, for
44 replacement parts for pump station operations within the County Executive's Office in the
45 aggregate amount of \$52,065.70, and further authorizes additional purchases in an amount not to
46 exceed \$47,934.30, for a total aggregate amount not to exceed \$100,000.00, for calendar year
