7 **A Resolution authorizing the County Executive to advertise for bids for the**
8 **Brandywine/Olde 8 Trunk Sewer Replacement Project (Q-182), in Northfield Center**
9 **Township, for an estimated total cost not to exceed \$304,830.00, for the Executive's**
10 **Department of Sanitary Sewer Services, and declaring an emergency.**

11
12 WHEREAS, the Brandywine/Olde 8 Trunk Sewer Replacement Project (Q-182)
13 ("Project"), in Northfield Center Township, in Council District 1, will replace settled and
14 deteriorated clay pipe sections so that they may be fully inspected, cleaned and maintained in a
15 fully functional condition; and

16
17 WHEREAS, the Project will be financed through the Ohio Water Development Authority
18 and repaid with Sewer District revenues; and

19
20 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
21 requires this Council's authorization for the County Executive to advertise for bids; and

22
23 WHEREAS, the County Executive wishes to advertise for the Project, for an estimated
24 total cost not to exceed \$304,830.00; and

26 WHEREAS, a copy of the plans and specifications are on file in the Clerk of Council's
27 office; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
31 advertise for bids for the Brandywine/Olde 8 Trunk Sewer Replacement Project (Q-182), in
32 Northfield Center Township, in Council District 1, in an estimated total cost not to exceed
33 \$304,830.00;

35 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
36 of Ohio, that:

40 The County Executive is hereby authorized to advertise for bids for the Brandywine/Olde
41 8 Trunk Sewer Replacement Project (Q-182), in Northfield Center Township, in Council District
42 1, in for an estimated total cost not to exceed \$304,830.00.

46 This Resolution is hereby declared an emergency in the interest of the health, safety and
47 welfare of the citizens of the County of Summit, and for the further reason that it authorizes the
48 Executive to immediately advertise for bids for the necessary replacement of sanitary sewer
49 pipes in Northfield Center Township.
