7 **A Resolution authorizing the County Executive to advertise for bids for the Middleton**
8 **Road Sanitary Sewer Improvement Project (Q-179), in the City of Hudson, for an**
9 **estimated total cost not to exceed \$1,628,150.00, for the Executive's Department of Sanitary**
10 **Sewer Services, and declaring an emergency.**

11
12 WHEREAS, it is necessary to replace sections of existing sanitary sewer pipe that are
13 failing on Middleton Road between the intersections of Darrow Road to a point about 850 east of
14 Hudson Park Drive, in the City of Hudson, in Council District 3; and

15
16 WHEREAS, the Middleton Road Sanitary Sewer Improvement (Q-179) Project will also
17 include the upgrade of the storm sewer system on Middleton Road; and

18
19 WHEREAS, the Project will be financed through a loan through the Ohio Water
20 Development authority and repaid through Sewer District revenue; and

21
22 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
23 requires this Council's authorization for the County Executive to advertise for bids; and

24
25 WHEREAS, this Council previously adopted Resolution No. 2016-207, which authorized
26 the County Executive to advertise for bids for the Project, for an estimated total cost not to
27 exceed \$1,350,000.00; and

28
29 WHEREAS, after the County received bids, no bidders were within 10% of the estimated
30 total cost not to exceed \$1,350,000.00; and

31
32 WHEREAS, the County Executive's Department of Sanitary Sewer Services' Engineer
33 has re-estimated the total cost as not to exceed \$1,628,150.00; and

34
35 WHEREAS, the Executive wishes to advertise for the Project, for an estimated total cost
36 not to exceed \$1,628,150.00; and

38 WHEREAS, a copy of the plans and specifications are on file in the Clerk of Council's
39 office; and

41 WHEREAS this Council finds and determines, after reviewing all pertinent information
42 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
43 advertise for bids for the Middleton Road Sanitary Sewer Improvement Project (Q-179), in the
44 City of Hudson, in Council District 3, for an estimated total cost not to exceed \$1,628,150.00;

46 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
47 of Ohio, that:

51 The County Executive is hereby authorized to advertise for bids for the Middleton Road
52 Sanitary Sewer Improvement Project (Q-179), in the City of Hudson, in Council District 3, for an

10 This Resolution is hereby declared an emergency in the interest of the health, safety and
11 welfare of the citizens of the County of Summit, and for the further reason that it authorizes the
12 Executive to immediately advertise for bids for the necessary repair of sanitary sewer pipe and
13 the upgrade of the storm sewer system on Middleton Road in the City of Hudson.

15 SECTION 3

17 Provided this Resolution receives the affirmative vote of eight members, it shall take
18 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
19 effect and be in force at the earliest time provided by law.

23 It is found and determined that all formal actions of this Council concerning and relating
24 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
25 deliberations of this Council and of any of its committees that resulted in such formal action,
