WHEREAS, the County of Summit has been awarded a grant from FirstEnergy Corp. by Ohio Partners for Affordable Energy ("OPAE") for the purpose of providing a variety of energy efficiency education and repair services to qualified residents through the County's Home Weatherization Assistance Program ("HWAP"), for the program period 6/1/16 through 5/31/17, in the amount of \$185,000.00, with no local cash match requirement; and

WHEREAS, the FirstEnergy Corp. funds are used to supplement HWAP funds required to perform repairs not covered by HWAP funds, such as electrical repairs; and

WHEREAS, it is necessary to authorize the County Executive a Community Connections Program Agreement with OPAE and any other documents necessary to accept the aforementioned grant from FirstEnergy Corp. and to appropriate the grant funds; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to execute a Community Connections Program Agreement with OPAE and any other documents necessary to accept the aforementioned grant, in the amount of \$185,000.00, with no local cash match requirement and to appropriate said grant funds;
