A Resolution authorizing the County Executive to execute an intergovernmental agreement with Medina County to create the Summit and Medina Workforce Area Council of Governments, to execute bylaws for said council of governments and to execute a Local Governance Agreement for Local Workforce Development Area Two, for the Executive's Department of Job and Family Services, and declaring an emergency.

WHEREAS, in 2014, the U.S. Congress enacted the Workforce Innovation and Opportunity Act ("WIOA") to amend the Workforce Investment Act of 1998 ("WIA") to strengthen the workforce development system through innovation in, and alignment and improvement of, employment, training, and education programs; and

WHEREAS, Summit and Medina Counties were designated as Area 2 under WIA and will continue as Area 2 under WIOA to administer workforce development activities whereby the chief elected officials play an active role in both strategic planning and ongoing operation of the local system and thus need agreements between their Chief Elected Officials ("CEOs") and the entities responsible for the workforce development system that will address the logistics of how the local area will function; and

WHEREAS, to implement the requirements of WIOA, the CEOs of Summit and Medina Counties have determined that the formation of a Council of Governments comprised of the two counties, and governed by an intergovernmental agreement, is the best structure by which to implement WIOA requirements and support the Workforce Development Board; and

WHEREAS, to further implement the requirements of WIOA, the CEOs must enter into an agreement with the Workforce Development Board to define the relationship and responsibilities of the parties; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute for the aforementioned reasons;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
