7 **A Resolution certifying deferred sewer tap-in fees to the Fiscal Officer, for the Executive's**
8 **Department of Sanitary Sewer Services, and declaring an emergency.**

10 WHEREAS, Section 923.05(d)(iii) of the Codified Ordinances of the County of Summit
11 grants Community Development Block Grant ("CDBG") recipients who connect to the
12 County's sanitary sewer system the option of placing their tap-in fee on their property tax
13 duplicate, without interest, for a period not to exceed twenty (20) years under an extended
14 payment program administered by the Executive's Department of Sanitary Sewer Services; and

15
16 WHEREAS, Section 923.05(e) of the Codified Ordinances of the County of Summit
17 provides that said deferred fees are to be certified to the Fiscal Officer and placed on the
18 property tax duplicate for collection; and

20 WHEREAS, this Council has determined by reviewing all the pertinent information that
21 certifying the aforementioned charges to the Fiscal Officer is necessary and in the best interest of
22 the County of Summit;

24 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
25 of Ohio, that:

29 The sewer tap-in fees of the following participants in the County's extended payment
30 program are hereby certified to the Fiscal Officer to be placed on the tax list and duplicate and
31 collected as other taxes are collected in the annual installments as stated below, payable
32 semiannually without interest, as provided by Section 923.05 of the Codified Ordinances and
33 Section 6117.02(B) of the Ohio Revised Code.
