A Resolution confirming an award by the Board of Control of an intergovernmental agreement with the Summit County Combined General Health District dba Summit County Public Health for Adult Protective Services care coordination services, for a one-year term, from 10/1/16 through 9/30/17, in a total amount not to exceed \$800,000.00, for the Executive's Department of Job and Family Services, and declaring an emergency.

WHEREAS, the Board of Control, at its meeting held September 7, 2016, awarded an intergovernmental agreement with the Summit County Combined General Health District dba Summit County Public Health for Adult Protective Services care coordination services, for a one-year term, from 10/1/16 through 9/30/17, in a total amount not to exceed \$800,000.00, subject to confirmation by County Council; and

WHEREAS, the intergovernmental agreement with the Summit County Combined General Health District dba Summit County Public Health is exempt from competitive bidding as another governmental unit pursuant to Section 177.07(a)(2) of the Codified Ordinances of the County of Summit; and

WHEREAS, this Council finds and determines after reviewing all pertinent information, that the aforementioned intergovernmental agreement with the Summit County Combined General Health District dba Summit County Public Health is necessary and in the best interest of the County of Summit;

NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

## SECTION 1

The award by the Board of Control of an intergovernmental agreement with the Summit County Combined General Health District dba Summit County Public Health for Adult Protective Services care coordination services, as set forth in Exhibit A, attached to this Resolution and incorporated herein as if fully restated, for a one-year term, from 10/1/16 through 9/30/17, in a total amount not to exceed \$800,000.00, is hereby confirmed and the County Executive is hereby authorized to execute such intergovernmental agreement.

## SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit, and for the further reason to immediately provide care coordination services effective 10/1/16.

## **SECTION 3**

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
