A Resolution authorizing the County Executive to execute a professional service contract with Lincoln Financial Group, subject to the approval of the Board of Control, to provide voluntary dental care benefits to County employees, for a one-year term, from 1/1/17 through 12/31/17, with two options to renew for an additional one-year term, for an estimated total amount not to exceed \$1,414,078.00, for the Executive's Department of Law, Insurance and Risk Management, and declaring an emergency.

WHEREAS, on behalf of the County of Summit, the County's consultant, NFP Corporate Services (OH), Inc., prepared and sent a request for proposals to vendors to provide various insurance services, including voluntary dental care benefits, to County employees; and

WHEREAS, NFP Corporate Services (OH), Inc. recommends that the County enter into a professional service contract with Lincoln Financial Group to provide voluntary dental care benefits to County employees, for a one-year term, from 1/1/17 through 12/31/17, with two options to renew for an additional one-year term, in an amount not to exceed a single rate of \$24.01 per month, and a family rate of \$71.15 per month for either of the two dental PPO Plans, for an estimated total amount not to exceed \$1,414,078.00; and

WHEREAS, the approval of the Board of Control will be required for said professional service contract with Lincoln Financial Group; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute the aforementioned professional service contract with Lincoln Financial Group, subject to the approval of the Board of Control, to provide voluntary dental care benefits to County employees;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The County Executive is hereby authorized to execute a professional service contract with Lincoln Financial Group, subject to the approval of the Board of Control, to provide voluntary dental care benefits to County employees, for a one-year term, from 1/1/17 through 12/31/17, with two options to renew for an additional one-year term, in an amount not to exceed a single rate of \$24.01 per month, and a family rate of \$71.15 per month for either of the two dental PPO Plans, for an estimated total amount not to exceed \$1,414,078.00.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit, and for the further reason to immediately authorize the Executive to execute a necessary professional service contract with Lincoln

Financial Group, subject to the approval of the Board of Control, to provide voluntary dental care benefits to County employees effective 1/1/17.
