A Resolution authorizing the County Executive to execute a collective bargaining agreement between Ohio Council 8 and Local 1229 of the American Federation of State, County and Municipal Employees, AFL-CIO (Auditor's/Recorder's Division of Fiscal Office), and the County Fiscal Officer and the County Executive, for the period 9/1/16 through 8/31/19, which authorizes a two and one-half percent (2.5%) increase in pay in each of the three years of the agreement, for the Executive's Department of Human Resources, and declaring an emergency.

WHEREAS, a collective bargaining agreement has been reached between the County Fiscal Officer and the County Executive and Ohio Council 8 and Local 1229 of the American Federation of State, County and Municipal Employees, AFL-CIO (Auditor's/Recorder's Division of Fiscal Office), for the period 9/1/16 through 8/31/19, which authorizes a two and one-half percent (2.5%) increase in pay in each of the three years of the agreement; and

WHEREAS, said collective bargaining agreement also applies to several bargaining unit employees transferred from the Fiscal Office to the Office of Information Technology; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that is necessary and in the best interest of the County of Summit to authorize the Executive to execute the aforementioned collective bargaining agreement;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
