7 **A Resolution authorizing the County Executive to execute any documents necessary to accept**
8 **an award from the Ohio Department of Public Safety, through its Ohio Traffic Safety Office,**
9 **for a countywide Operating a Motor Vehicle While Intoxicated Task Force program, for the**
10 **period 10/1/16 to 9/30/17, in the amount of \$225,000.00, with no local cash match requirement,**
11 **and confirming an award by the Board of Control of a general encumbrance purchase order**
12 **for payments to various law enforcement agencies participating in the Task Force, for the**
13 **period 10/1/16 to 9/30/17, in the amount of \$122,125.07, and appropriating said grant funds,**
14 **for the Sheriff, and declaring an emergency.**

16 WHEREAS, the Ohio Department of Public Safety, through the Ohio Traffic Safety Office,
17 has awarded the County Sheriff a grant for a countywide Operating a Motor Vehicle While
18 Intoxicated (“OVI”) Task Force program, for the period 10/1/16 to 9/30/17, in the amount of
19 \$225,000.00, with no local cash match requirement, in order to conduct high visibility enforcement,
20 public awareness, and education for alcohol-related crashes and traffic-related fatalities in Summit
21 County; and

23 WHEREAS, the Board of Control, at its meeting held September 21, 2016, awarded a
24 general encumbrance purchase order for payments to various law enforcement agencies participating
25 in the OVI Task Force for services provided, for the period 10/1/16 to 9/30/17, in the amount of
26 \$122,125.07; and

28 WHEREAS, it is necessary to appropriate said grant funds, in the amount of \$225,000.00;

31 WHEREAS, this Council finds and determines, after reviewing all pertinent information, that
32 authorizing the County Executive to execute any documents necessary to accept the aforementioned
33 grant for the OVI Task Force, to confirm the award by the Board of Control of the aforementioned
34 general encumbrance purchase order and to appropriate said grant funds;

36 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of




