SECTION 1

The award by the Board of Control of renewal (second and final) of a professional service contract with Wellness IQ, Inc. to provide vitality wellness services to and for the benefit of County of Summit employees and employees of other entities participating in the County's health insurance plan, for a one-year term, from 11/1/16 through 10/31/17, for an estimated total amount not to exceed \$195,000.00, is hereby confirmed and the County Executive is hereby authorized to execute such renewal of said professional service contract.
