WHEREAS, the Board of Control, at its meeting held October 12, 2016, awarded a professional service contract with Davis Vision, Inc. to provide voluntary vision insurance for County employees, for a one-year term, from 1/1/17 through 12/31/17, with two options to renew for an additional one year term, in an amount not to exceed a single rate of \$3.47 per month and a family rate of \$9.54 per month, for an estimated total amount not to exceed \$160,000.00, subject to confirmation by County Council; and
