A Resolution confirming an award by the Board of Control of a professional service contract with Benefit Administrative Services International Corporation d.b.a. WHEREAS, on behalf of the County of Summit, the County's consultant, NFP Corporate Services (OH), Inc., prepared and sent a request for proposals to vendors to provide health reimbursement account and flexible spending account administration services for County employees and the County has selected Benefit Administrative Services International Corporation d.b.a. BASIC as being the lowest responsive and responsible vendor; and

WHEREAS, the Board of Control, at its meeting held October 12, 2016, awarded a professional service contract with Benefit Administrative Services International Corporation d.b.a.
