WHEREAS, at a Summit County Board of Elections meeting held on September 20, 2016, a Motion was approved by board members to request these funds, in the amount of \$61,150.22, be appropriated for the purpose of reimbursing the actual costs of the August 2, 2016 special election and refunding the aforementioned political subdivisions the overpayments as calculated on Exhibit A; and
