A Resolution authorizing the County Executive to conduct an auction, through Akron Auto Auction, of various surplus Sheriff's Office vehicles, with a total fair market value exceeding \$38,000.00, for a cost to the County of an amount not to exceed \$3,800.00, and authorizing the Executive to execute any documents with Akron Auto Auction necessary to conduct said auction, for the Executive, and declaring an emergency.

WHEREAS, the County Sheriff's Office has various surplus vehicles as set forth in attached Exhibit A; and

WHEREAS, the Sheriff's Office wishes to have the County Executive auction said vehicles, which have a total fair market value exceeding \$38,000.00, which requires the approval of County Council pursuant to Section 177.18 of the Codified Ordinances of the County of Summit; and

WHEREAS, the Executive intends to conduct said auction through Akron Auto Auction at a cost to the County of \$125.00 per vehicle for the auction including pick up of each unit, and \$65.00 per vehicle in the event the unit needs towed, for a total cost to the County of an amount not to exceed \$3,800.00; and

WHEREAS, it is necessary to authorize the Executive to execute any documents with Akron Auto Auction necessary to conduct said auction; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to conduct an auction, through Akron Auto Auction, of various surplus Sheriff's Office vehicles, as set forth in attached Exhibit A, with a total fair market value exceeding \$38,000.00, for a cost to the County of an amount not to exceed \$3,800.00, and to authorize the Executive to execute any documents with Akron Auto Auction necessary to conduct said auction;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

The County Executive is hereby authorized to conduct an auction, through Akron Auto Auction, of various surplus Sheriff's Office vehicles, as set forth in Exhibit A, attached to this Resolution and incorporated herein as if fully restated, with a total fair market value exceeding \$38,000.00. The cost to the County shall not exceed the amount of \$125.00 per vehicle for the auction including pick up of each unit, and \$65.00 per vehicle in the event the unit needs to be towed, for a total cost to the County of an amount not to exceed \$3,800.00. The Executive is further authorized to execute any documents with Akron Auto Auction necessary to conduct said auction.
