11 WHEREAS, the Court of Common Pleas-General Division, has cash reserves, in the  
12 amount of \$634,870.00 from fees collected from probation clients for services provided by the  
13 Court's Adult Probation Department; and

15 WHEREAS, it is necessary to appropriate funds, in the amount of \$20,000.00, from the  
16 aforementioned reserve funds, for operating costs through 12/31/16; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
19 that it is necessary and in the best interest of the County of Summit to appropriate funds, in the  
20 amount of \$20,000.00, for operating costs for the Adult Probation Department through 12/31/16;


