A Resolution confirming an award by the Board of Control of a renewal (second and final) of a professional service contract with Key Bank for bank depository and remittance lock box services, for a two year period, from 1/1/17 to 12/31/18, in a total amount not to exceed \$228,013.65, for the Fiscal Officer, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution No. 2012-477, which confirmed an award by the Board of Control of a professional service contract with Key Bank, as a Best Practical Source, for a combined bank depository and remittance lock box services, for a two-year term, from 1/3/13 to 12/31/14, in an amount not to exceed \$228,013.65, with two options to renew for an additional two-year term; and

WHEREAS, this Council previously adopted Resolution No. 2015-107, which confirmed an award by the Board of Control of a renewal (first of two) of a professional service contract with Key Bank, for bank depository and remittance lock box services, for the period 1/1/15 to 12/31/16, in a total amount not to exceed \$228,013.65; and

WHEREAS, the Board of Control, at its meeting held October 26, 2016, awarded a renewal (second and final) of a professional service contract with Key Bank for bank depository and remittance lock box services, for a two-year term, from 1/1/17 to 12/31/18, in an amount not to exceed \$228,013.65, subject to confirmation by County Council; and

WHEREAS, this Council finds and determines after reviewing all pertinent information, that the aforementioned two-year renewal (second and final) of a professional service contract with Key Bank is necessary and in the best interest of the County of Summit;

NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
