A Resolution authorizing the County Executive to execute an intergovernmental agreement with the County Court of Common Pleas-General Division, pursuant to which the County, through the Office of Information Technology, will provide internet service to the Court, for a one-year term, from 11/1/16 through 10/31/17, with two options to renew for an additional one-year term, for an amount not to exceed \$300.00 per month or \$3,600.00 annually, and ratifying the County Executive's execution of a similar agreement with the Court of Common Pleas-Probate Division, for the Office of Information Technology, and declaring an emergency.

WHEREAS, the County of Summit wishes to enter into an intergovernmental agreement with the County Court of Common Pleas-General Division, pursuant to which the County, through Office of Information Technology, will provide internet service to the Court via a 100 Mbps High Availability Internet Connection, for a one-year term, from 11/1/16 through 10/31/17, with two options to renew for an additional one-year term, for an amount not to exceed \$300.00 per month or \$3,600.00 annually; and

WHEREAS, the Information Technology Board adopted Directive No. IT 2016-23, which approved said intergovernmental agreement; and

WHEREAS, the County Executive previously executed an intergovernmental agreement with the County Court of Common Pleas-Probate Division, pursuant to which the County, through the Office of Information Technology, will provide internet service to the Court via a 100 Mbps High Availability Internet Connection, for a one-year term, from 7/1/16 through 6/30/17, with two options to renew for an additional one-year term, for an amount not to exceed \$300.00 per month or \$3,600.00 annually; and

WHEREAS, the Executive's execution of said intergovernmental agreement with the County Court of Common Pleas-Probate Division, requires ratification by County Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that is necessary and in the best interest of the County of Summit to authorize the Executive to execute the aforementioned intergovernmental agreement with the Court of Common Pleas-General Division and to ratify the Executive's execution of the aforementioned intergovernmental agreement with the Court of Common Pleas-Probate Division;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

## SECTION 1

The County Executive is hereby authorized to execute an intergovernmental agreement with the County Court of Common Pleas-General Division, pursuant to which the County, through the Office of Information Technology, will provide internet service to the Court via a 100 Mbps High Availability Internet Connection, for a one-year term, from 11/1/16 through 10/31/17, with two options to renew for an additional one-year term, for an amount not to exceed \$300.00 per month or \$3,600.00 annually. The Executive is hereby authorized to execute the

#### **SECTION 2**

The County Executive's execution of an intergovernmental agreement with the County Court of Common Pleas-Probate Division, pursuant to which the County, through the Office of Information Technology, will provide internet service to the Court via a 100 Mbps High Availability Internet Connection, for a one-year term, from 7/1/16 through 6/30/17, with two options to renew for an additional one-year term, for an amount not to exceed \$300.00 per month or \$3,600.00 annually, is hereby ratified by this Council.

## **SECTION 3**

This Resolution is hereby declared an emergency in the interest of the health, safety, and welfare of the citizens of the County of Summit and for the further purpose of immediately authorizing the Executive to execute a necessary intergovernmental agreement with the Court of Common Pleas-General Division for the provision of internet service through the Office of Information Technology and immediately ratifying the Executive's execution of similar agreement with the Court of Common Pleas-Probate Division.

## **SECTION 4**

Provided this Resolution received the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

## **SECTION 5**

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
