A Resolution authorizing the County Executive and County Fiscal Officer to Execute a Special Assessment Agreement with the City of Akron, Akron Energy Special Improvement District, Cascade Plaza Associates, LLC and Greenworks Lending, LLC pertaining to a Special Energy Improvement Project at the Cascade Plaza Building located in downtown Akron, for the Executive and Fiscal Officer, and declaring an emergency.

WHEREAS, the City of Akron, Akron Energy Special Improvement District, Cascade Plaza Associates, LLC and Greenworks Lending, LLC are parties to a certain Energy Project Cooperative Agreement whereby certain energy-efficient improvements are to be made to the Cascade Plaza Building in downtown Akron ("Special Energy Improvement Project"), and the costs of the same will be assessed against the property and paid as assessments by Cascade Plaza Associates, LLC; and

WHEREAS, in conjunction with the Special Energy Improvement Project, the remaining parties have requested that the County execute a Special Assessment Agreement (the "Agreement") whereby the terms and conditions of the actions to be taken by the County in the event of a default in payment by Cascade Plaza Associates, LLC are set forth, a copy of the same is attached hereto and incorporated herein by reference; and

WHEREAS, the County Executive and County Fiscal Officer have reviewed the Agreement and have recommended that this Council authorize their execution of the same in order to encourage development in downtown Akron; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County to authorize the County Executive and County Fiscal Officer to execute the Agreement.

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
