A Resolution confirming an award by the Board of Control of a renewal (first of four) a professional service contract with Aramark Correctional Services, LLC for food services at the Summit County Jail and the Glenwood Jail, for a one-year term, from 12/1/16 through 11/30/17, for a total amount not to exceed \$700,000.00, for the Sheriff, and declaring an emergency.

WHEREAS, County Council previously adopted Resolution No. 2015-458, which confirmed an award by the Board of Control of a purchase contract with Aramark Correctional Services, LLC to provide food services at the Summit County Jail and Glenwood Jail, for a one-year term, from 12/1/15 through 11/30/16, with four options to renew for an additional one-year term, in an amount not to exceed \$700,000.00; and

WHEREAS, the Board of Control, at its meeting held December 7, 2016, awarded a renewal (first of four) of a professional service contract with Aramark Correctional Services, LLC for food services at the Summit County Jail and the Glenwood Jail, for a one-year term, from 12/1/16 through 11/30/17, in an amount not to exceed \$700,000.00, subject to approval by County Council; and

WHEREAS, County Council finds and determines, after reviewing all pertinent information that the renewal of the aforementioned professional service contract is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:
