A Resolution confirming an award by the Board of Control of a construction contract with Cook Paving and Construction Co., Inc. for the improvement of the intersection of Cleveland Massillon Road at the western leg of Ridgewood Road on the border between Copley Township and the City of Fairlawn, in Council District 5, in an amount not to exceed \$396,697.40, for the Engineer, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution No. 2019-452, which authorized the County Executive to advertise as needed for bridge engineering and construction projects, and pavement maintenance projects, for the Engineer's 2020 Capital Improvements Program, for an estimated total cost not to exceed \$5,290,750.00; and

WHEREAS, it is necessary to make an improvement to the intersection of Cleveland Massillon Road at the western leg of Ridgewood Road on the border between Copley Township and the City of Fairlawn, in Council District 5 (the "Project"); and

WHEREAS, the Project will provide a new south bound right turn lane on Cleveland Massillon Road from the Rothrock Circle intersection to Ridgewood Road, provide a new east bound left turn lane on Ridgewood Road at the intersection and extending 400 feet to the west, reconstruct the existing traffic signal installation, including new signal supports, and modify the existing storm water collection basin near the intersection; and

WHEREAS, following the receipt and review of bids, the County Executive proposes entering into a construction contract with Cook Paving and Construction Co., Inc. for the Project, in an amount not to exceed \$396,697.40; and

WHEREAS, the Board of Control, at its meeting held May 20, 2020, awarded a construction contract with Cook Paving and Construction Co., Inc. for the Project, in an amount not to exceed \$396,697.40, subject to confirmation by County Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that aforementioned construction contract with Cook Paving and Construction Co., Inc. is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that;
