7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **contract with Kronos, Inc., as a Sole Source, to provide Software as a Service Cloud**  
9 **licenses and software support for the County's time-tracking system, for a one-year term,**  
10 **from 7/13/20 through 7/12/21, in an amount not to exceed \$157,833.60, for the Office of**  
11 **Information Technology, and declaring an emergency.**

13 WHEREAS, Kronos, Inc. implemented the County's time-tracking system and is a Sole  
14 Source for the software and services for that system; and

15  
16 WHEREAS, the Office of Information Technology recommends that the County enter  
17 into a professional service contract with Kronos, Inc., as a Sole Source, to provide Software as a  
18 Service Cloud licenses and software support for the County's time-tracking system, for a one-  
19 year term, from 7/13/20 through 7/12/21, in an amount not to exceed \$157,833.60; and

21 WHEREAS, the IT Board, at its meeting held May 14, 2020, approved said professional  
22 service contract with Kronos, Inc. and

24 WHEREAS, the Board of Control, at its meeting held May 20, 2020, awarded said  
25 professional service contract with Kronos, Inc., subject to confirmation by County Council; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
28 that aforementioned professional service contract with Kronos, Inc. is necessary and in the best  
29 interest of the County of Summit;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
32 of Ohio, that;

36 The award by the Board of Control of a professional service contract with Kronos, Inc.,  
37 as a Sole Source, to provide Software as a Service Cloud licenses and software support for the  
38 County's time-tracking system, for a one-year term, from 7/13/20 through 7/12/21, in an amount  
39 not to exceed \$157,833.60, is hereby confirmed and the County Executive is hereby authorized  
40 to execute such professional service contract and any other necessary related documents.

44 This Resolution is hereby declared an emergency in the interest of the health, safety and  
45 welfare of the residents of the County of Summit, and for the further purpose to immediately  
46 authorize a necessary contract to maintain the County's time-tracking system for County  
47 employees.



8 effect and be in force at the earliest time provided by law.



16 121.22 of the Ohio Revised Code.


