WHEREAS, County Council previously adopted Resolution No. 2018-214, which confirmed an award by the Board of Control of a professional service contract with Wichert Insurance Services, Inc. dba Wichert Insurance, ("Wichert") to provide brokerage services for the County's property, liability and boiler and machinery insurance program, and to provide Claim Reporting Services using Riskmaster, for a one-year term, from 7/1/18 through 6/30/19, in an amount not to exceed \$45,000.00; and
