7 **A Resolution authorizing the County Executive to execute a collective bargaining**
8 **agreement between Ohio Council 8 and Local 1229 of the American Federation of State,**
9 **County and Municipal Employees, AFL-CIO (Communication Technician Unit), and the**
10 **County Executive and County Sheriff, for the period 4/1/20 through 3/31/21, which**
11 **authorizes a two and one-half percent (2.5%) increase in pay, for the County Executive and**
12 **the County Sheriff, and declaring an emergency.**

14 WHEREAS, a collective bargaining agreement has been reached between Ohio Council 8
15 and Local of the American Federation of State, County and Municipal Employees, AFL-
16 CIO1229 (Communication Technician Unit), and the County Executive and County Sheriff, for
17 the period 4/1/20 through 3/31/21, which authorizes a two and one-half percent (2.5%) increase
18 in pay; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that it is necessary and in the best interest of the County of Summit to authorize the County
22 Executive to execute the aforementioned collective bargaining agreement and any necessary
23 related documents;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
26 of Ohio, that:

28 SECTION 1

30 The County Executive is hereby authorized to execute a collective bargaining agreement
31 between Ohio Council 8 and Local 1229 of the American Federation of State, County and
32 Municipal Employees, AFL-CIO (Communication Technician Unit), and the County Executive
33 and County Sheriff, for the period 4/1/20 through 3/31/21, which authorizes a two and one-half
34 percent (2.5%) increase in pay and any necessary related documents.

38 This Resolution is hereby declared an emergency in the interest of the health, safety, and
39 welfare of the residents of the County of Summit and for the further purpose of providing a
40 timely collective bargaining agreement between Ohio Council 8 and Local 1229 of the American
41 Federation of State, County and Municipal Employees, AFL-CIO (Communication Technician
42 Unit), and the County Executive and County Sheriff.

46 Provided this Resolution received the affirmative vote of eight members, it shall take
47 effect immediately upon its adoption and approval by the County Executive; otherwise, it shall
48 take effect and be in force at the earliest time provided by law.
