A Resolution, pursuant to Section 169.04(i) of the Codified Ordinances of the County of Summit, entitled "Temporary Hiring Freeze," to authorize the County Executive to hire a Forensic Investigator, for the County Executive, and declaring an emergency.

WHEREAS, this Council previously adopted Ordinance No. 2020-095, which enacted Section 169.04(i) of the Codified Ordinances of the County of Summit, entitled, "Temporary Hiring Freeze," due to the anticipated economic crisis and related budgetary concerns resulting from the COVID-19 pandemic and the State of Ohio's Stay at Home Order; and

WHEREAS, Section 169.04(i) provides that if a County office is able to demonstrate that the filling of an existing position by hiring an employee is necessary for the effective and continued operation of the office, Council may adopt a Resolution authorizing the office to hire said employees; and

WHEREAS, an employee in the position of Forensic Investigator, a bargaining unit position at the Summit County Medical Examiner's Office, will be resigning effective 8/1/20, leaving the position vacant; and

WHEREAS, because of the critical functions of said position, it is necessary for the County Executive to fill the vacated Forensic Investigator position in order for the Summit County Medical Examiner's Office to operate effectively and efficiently; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the County Executive to hire a new Forensic Investigator;
