7 **A Resolution confirming an award by the Board of Control of a purchase contract with**  
8 **Bridgestone Americas, Inc., as a Best Practical Source, for customer sanitary sewer utility**  
9 **billing services, in an amount not to exceed \$57,500.00, for the County Executive's**  
10 **Department of Sanitary Sewer Services, and declaring an emergency.**

11  
12 WHEREAS, the County Executive's Department of Sanitary Sewer Services has  
13 outsourced customer sanitary sewer utility billing services, such as the printing, folding,  
14 inserting, sorting and delivery of bills to the U.S. Postal Service; and

15  
16 WHEREAS, Bridgestone Americas, Inc. has performed said customer sanitary sewer  
17 utility billing services for the County since 2012; and

18  
19 WHEREAS, based upon 2019 figures, the cost for each sanitary sewer utility bill  
20 processed and delivered will be \$0.53; and

21  
22 WHEREAS, the Board of Control, at its meeting held July 1, 2020, awarded a purchase  
23 contract with Bridgestone Americas, Inc., as a Best Practical Source, for customer sanitary sewer  
24 utility billing services, in an amount not to exceed \$57,500.00, subject to confirmation by County  
25 Council; and

27 WHEREAS, this Council finds and determines after reviewing all pertinent information,  
28 that the aforementioned purchase contract with Bridgestone Americas, Inc. is necessary and in  
29 the best interest of the County of Summit;

31 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
32 of Ohio, that:

34 SECTION 1

36 The award by the Board of Control of a purchase contract with Bridgestone Americas,  
37 Inc., as a Best Practical Source, for customer sanitary sewer utility billing services, in an amount  
38 not to exceed \$57,500.00, is hereby confirmed and the County Executive is hereby authorized to  
39 execute said purchase contract and any necessary related documents.

43 This Resolution is hereby declared an emergency in the interest of the health, safety and  
44 welfare of the residents of the County of Summit, and for the further reason to immediately  
45 provide for the continuation of customer sanitary sewer utility billing services in 2020.

49 Provided this Resolution receives the affirmative vote of eight members, it shall take  
50 effect immediately upon its adoption and approval by the County Executive; otherwise, it shall  
51 take effect and be in force at the earliest time provided by law.
