7 **A Resolution authorizing the Executive to execute a collective bargaining agreement**
8 **between the Fraternal Order of Police, Ohio Labor Council, Inc., and the County**
9 **Executive and County Sheriff, for the period 1/1/20 through 12/31/22, which authorizes a**
10 **two and one-half percent (2.5%) increase in pay in the year 2020, with a wage reopener for**
11 **the remaining two years of the agreement, for the Executive and the Sheriff, and declaring**
12 **an emergency.**

13

14 WHEREAS, a collective bargaining agreement has been reached between the Fraternal
15 Order of Police, Ohio Labor Council, Inc. (representing the full-time Deputy Sheriffs), and the
16 County Executive and County Sheriff, for the period 1/1/20 through 12/31/22, which authorizes
17 a two and one-half percent (2.5%) increase in pay for the first year of the agreement, and a wage
18 reopener for the remaining two years of the agreement; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
21 that is necessary and in the best interest of the County of Summit to authorize the Executive to
22 execute the aforementioned collective bargaining agreement and any other necessary related
23 documents;

25 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
26 of Ohio, that:

28 SECTION 1

30 The County Executive is hereby authorized to execute a collective bargaining agreement
31 between the Fraternal Order of Police, Ohio Labor Council, Inc., and the County Executive and
32 County Sheriff, for the period 1/1/20 through 12/31/22, which authorizes a two and one-half
33 percent (2.5%) increase in pay for the first year of the agreement and a wage reopener for the
34 remaining two years of the agreement and any other necessary documents.

38 This Resolution is hereby declared an emergency in the interest of the health, safety, and
39 welfare of the residents of the County of Summit and for the further purpose of providing a
40 timely collective bargaining agreement between the Fraternal Order of Police, Ohio Labor
41 Council, Inc., and the County Executive and County Sheriff.

45 Provided this Resolution received the affirmative vote of eight members, it shall take
46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
47 effect and be in force at the earliest time provided by law.
