7 **A Resolution confirming an award by the Board of Control of professional service**
8 **contracts with certain providers of delinquent care and custody grant services, for the**
9 **period 7/1/20 through 6/30/21, in a total amount not to exceed \$934,634.00, for the Court of**
10 **Common Pleas-Juvenile Division, and declaring an emergency.**

11
12 WHEREAS, the Court of Common Pleas-Juvenile Division has received a State Fiscal
13 Year 2021 Ohio Department of Youth Services Delinquent Care & Custody grant, in the amount
14 of \$4,502,734.68, for the period 7/1/20 through 6/30/21, that allows local courts to develop or
15 purchase a range of community based services to meet the needs of juvenile offenders or youth at
16 risk of offending; and

18 WHEREAS, the Board of Control, at its meeting held July 22, 2020, awarded
19 professional service contracts with the providers set forth in Exhibit A, for delinquent care and
20 custody grant services, for the period 7/1/20 through 6/30/21, in a total amount not to exceed
21 \$934,634.00, subject to confirmation by County Council; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that the aforementioned professional service contracts with certain providers are necessary and in
25 the best interest of the County of Summit;

27 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
28 of Ohio, that:

32 The award by the Board of Control of professional service contracts with certain
33 providers, for delinquent care and custody grant services, for the period 7/1/20 through 6/30/21,
34 in a total amount not to exceed \$934,634.00 is hereby confirmed, and the Executive is hereby
35 authorized to execute the aforementioned professional service contracts and any necessary
36 related documents with the providers set forth in Exhibit A.

40 This Resolution is hereby declared an emergency in the interest of the health, safety and
41 welfare of the residents of the County of Summit, and for the further reason to immediately
42 provide for delinquent care and custody grant services effective 7/1/20.

47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
48 effect and be in force at the earliest time provided by law.


