A Resolution certifying delinquent Surface Water Management District charges to the Fiscal Officer, for the Engineer, and declaring an emergency.

WHEREAS, the billing records at the Engineer's office show delinquent surface water utility accounts which represent unpaid charges; and

WHEREAS, Section 942.07(d) of the County of Summit Codified Ordinances provides that these charges are to be certified to the Fiscal Officer and placed on the real property tax list and duplicate against the property for collection; and

WHEREAS, the delinquent Surface Water Management charges shall be levied in the 2021 collection year and split equally between 1st and 2nd half collections; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to certify the aforementioned charges to the Fiscal Officer;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

The delinquent surface water utility accounts listed in Exhibit A, attached hereto and incorporated herein as if fully, restated, are hereby certified to the Fiscal Officer to be placed on the real property tax list and duplicate on their respective parcels for collection in 2021.

The Clerk of Council shall deliver a copy of this Resolution to the Fiscal Officer who shall record the delinquent surface water utility charges for collection pursuant to the County of Summit Codified Ordinances.

This Resolution is hereby declared an emergency in the interest of the health, safety, and welfare of the resident of the County of Summit, and for the further reason to immediately ensure the certification of charges to the Fiscal Officer.
