A Resolution authorizing the Executive, subject to the approval of the Board of Control, to execute an agreement with the United Way of Summit and Medina Counties in a total amount not to exceed \$1,000,000.00 to be paid from Temporary Assistance for Needy Families ("TANF") funds, and declaring such expenditure necessary due to the public health emergency with respect to the Coronavirus Disease 2019 (COVID-19), for the Executive, and declaring an emergency.

WHEREAS, the Coronavirus Disease 2019 (COVID-19) has had a significant impact on the health and wellbeing of the residents of Summit County and has dramatically impacted many residents financially, rendering them unable to cover all of the normal expenses of living; and

WHEREAS, the County, the United Way of Summit and Medina Counties (the "United Way"), Community Legal Aid, Fair Housing Contact Service and the Battered Women's Shelter of Summit and Medina Counties have partnered, in cooperation with the City of Akron, to establish a rental and mortgage assistance program geared toward ensuring that Summit County residents who have been thus impacted are able to remain in their place of residence which will be called the Summit County CARES Program (the "Program"); and

WHEREAS, this Council previously adopted Resolution No. 2020-197, which authorized the Executive to establish the Summit County CARES Program and provided funding not to exceed \$6,500,000.00, utilizing \$5,000,000.00 of CARES Act funds and \$1,500,000.00 of a combination of TANF and Title XX; and

WHEREAS, the Executive wishes to execute an agreement with the United Way in an amount not to exceed \$1,000,000.00, utilizing TANF funds to provide additional funding to the Program; and

WHEREAS, this matter will appear before the Board of Control at its meeting on September 2, 2020; and

WHEREAS this Council finds and determines, after reviewing all pertinent information, that and the aforementioned agreement with the United Way is necessary and in the best interest of the County of Summit.
