7 **A Resolution pursuant to Section 169.04(i) of the Codified Ordinances of the County of**
8 **Summit, entitled “Temporary Hiring Freeze” to authorize the Executive to hire a Plant**
9 **Pump Station Superintendent as a replacement, for the Executive’s Department of**
10 **Sanitary Sewer Services, and declaring an emergency.**

11
12 WHEREAS, this Council previously adopted Ordinance No. 2020-095, which enacted
13 Section 169.04(i) of the Codified Ordinances of the County of Summit, entitled, “Temporary
14 Hiring Freeze,” due to the anticipated economic crisis and related budgetary concerns resulting
15 from the Coronavirus Disease 2019 (“COVID-19”) pandemic; and

16
17 WHEREAS, Section 169.04(i) provides that if a County office is able to demonstrate that
18 the filling of an existing position by hiring an employee is necessary for the effective and
19 continued operation of the office, Council may adopt a resolution authorizing the office to hire
20 said employee(s); and

22 WHEREAS, due to an employee retirement at the Executive’s Department of Sanitary
23 Sewer Services, it is necessary to hire a Plant Pump Station Superintendent with a Class IV
24 Wastewater Treatment Operator’s license, as mandated by the State of Ohio Environmental
25 Protection Agency; and

27 WHEREAS, this Council has determined, after reviewing all pertinent information, that it
28 is necessary and in the best interest of the County of Summit to authorize the Executive to hire a
29 Plant Pump Station Superintendent;

31 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
32 State of Ohio, that:

34 SECTION 1

36 This Council hereby determines that the Executive has demonstrated that it is necessary
37 for the effective and continued operation of his office to authorize the Executive, pursuant to
38 Section 169.04(i) of the Codified Ordinances of the County of Summit, to hire a Plant Pump
39 Station Superintendent.

41 SECTION 2

43 This Resolution is hereby declared an emergency in the interest of the health, safety and
44 welfare of the residents of the County of Summit and for the further reason to immediately
45 authorize the Executive to hire a Plant Pump Station Superintendent in order to replace a retired
46 employee.

50 Provided this Resolution receives the affirmative vote of eight members, it shall take
51 effect immediately upon its adoption and approval by the Executive; otherwise it shall take effect
52 and be in force at the earliest time provided by law.
