7 **A Resolution confirming an award by the Board of Control of a construction contract with**  
8 **The Great Lakes Construction Co. for the West Bath Road Landslide Mitigation Project,**  
9 **located in Bath Township, in Council District 4, in an amount not to exceed \$1,040,068.57,**  
10 **for the Engineer, and declaring an emergency.**

11  
12 WHEREAS, the Engineer is undertaking the West Bath Road Landslide Mitigation  
13 Project (the "Project"), which will stabilize and repair the landslide along West Bath Road,  
14 located approximately 250 feet to the east of the North Revere Run intersection, located in Bath  
15 Township, in Council District 4; and

16  
17 WHEREAS, slope repair will be performed on the downward slope side of the roadway  
18 and a retaining wall will be constructed on the upward slope side of the roadway and in addition,  
19 600 feet of West Bath Road will be reconstructed with a lower profile; and

20  
21 WHEREAS, the Project was included in the 2020 Capital Budget; and

22  
23 WHEREAS, this Council previously adopted Resolution No. 2020-045, which authorized  
24 the Executive to advertise for bids for the Project, in an amount not to exceed \$1,600,000.00; and

25  
26 WHEREAS, after the solicitation of bids, the Engineer selected The Great Lakes  
27 Construction Co. as the lowest responsive and responsible bidder; and

28  
29 WHEREAS, due to winter typically being a slow season for construction projects and due  
30 to the high amount of interest in the Project, all nine submitted bids were much more competitive  
31 and significantly lower than anticipated; and

33 WHEREAS, the Board of Control, at its meeting held September 16, 2020, awarded a  
34 construction contract with The Great Lakes Construction Co. for the Project, in an amount not to  
35 exceed \$1,040,068.57; and

36  
37 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
38 that the aforementioned construction contract with The Great Lakes Construction Co. is  
39 necessary and in the best interest of the County of Summit; and

41 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
42 of Ohio, that:

46 The award by the Board of Control of a construction contract with The Great Lakes  
47 Construction Co. for the West Bath Road Landslide Mitigation Project, located in Bath  
48 Township, in Council District 4, in an amount not to exceed \$1,040,068.57, is hereby confirmed  
49 and the Executive is hereby authorized to execute said construction contract and any other  
50 necessary related documents.

7 of the residents of the County of Summit, and for the further reason that it will allow the West  
8 Bath Road Landslide Mitigation Project to proceed in an expeditious fashion.

12 Provided this Resolution receives the affirmative vote of eight members, it shall take  
13 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
14 effect and be in force at the earliest time provided by law.

18 It is found and determined that all formal actions of this Council concerning and relating  
19 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
20 deliberations of this Council and any of its committees that resulted in such formal action, were

22 121.22 of the Ohio Revised Code.
