A Resolution authorizing the Executive to execute any documents necessary to accept a Fiscal Year 2020 Emergency Management Performance Grant of federal reimbursement funds from the State of Ohio Department of Public Safety, Emergency Management Agency, for the period 10/1/19 through 9/30/21, in the amount of \$182,567.53, and authorizing the expenditure of \$182,567.53 for the County's 50% local cash match requirement, for the Executive's Department of Law and Risk Management – Division of Public Safety/Emergency Management Agency, and declaring an emergency.

WHEREAS, the State of Ohio Department of Public Safety, Ohio Emergency Management Agency ("OEMA"), has awarded the County of Summit Emergency Management Agency ("SCEMA") a Fiscal Year 2020 Emergency Management Performance grant for the period 10/1/19 through 9/30/21, in the amount of \$182,567.53 in federal funds, as reimbursement for operational activities with the cost-share, cash-match requirement that an equal amount of operational activities be paid by the County with non-federal funds; and

WHEREAS, Section 130.04 of the Codified Ordinances of the County of Summit requires Council approval for the Executive to execute a grant agreement where the County's match amount exceeds \$25,000.00; and

WHEREAS, this Council previously adopted Resolution No. 2019-439, which approved the 2020 annual operating budget for the County, including \$667,800.00 for the Emergency Management Agency's operational activities, which will fulfill grant requirements for matching and reimbursements; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that is it necessary and in the best interest of the County to authorize the Executive to execute any documents necessary to accept the award of the aforementioned grant from OEMA, in the amount of \$182,567.53, and to authorize the expenditure of \$182,567.53 for the County's 50% local cash match requirement;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State of Ohio, that:

## SECTION 1

The Executive is hereby authorized to execute any documents necessary to accept the Fiscal Year 2020 Emergency Management Performance Grant award to the County of Summit Emergency Management Agency for the period 10/1/19 through 9/30/21, in the amount of \$182,567.53, and the expenditure of \$182,567.53 is hereby authorized for the County's 50% local cash match requirement.
