7 **An Ordinance enacting Chapter 140 of the Codified Ordinances of the County of Summit**
8 **entitled “Reports,” to permit the Sheriff to provide required reports at the time of the**
9 **Sheriff’s budget presentation, for the Sheriff, and declaring an emergency.**

10
11 WHEREAS, Section 3, Article X of the Ohio Constitution provides that “[t]he people of
12 any county may frame and adopt . . . a charter . . .;” and

13
14 WHEREAS, the voters of the County of Summit approved the adoption of the County
15 Charter on November 6, 1979; and

16
17 WHEREAS, Article IV, Section 4.01(1) of the County Charter provides that “[t]he Clerk
18 of the Court of Common Pleas, County Engineer, Prosecuting Attorney and the Sheriff of the
19 County shall be elected and their duties shall continue to be determined in the manner provided
20 by general law, except where County Council changes those duties by ordinance or resolution...”

21
22 WHEREAS, Sections 311.16 and 311.20 require the Sheriff to provide certain reports to
23 this Council every June and September concerning costs at the Summit County Jail and the
24 collection of fine and costs in criminal prosecutions; and

25
26 WHEREAS, this Council wishes to receive the aforementioned reports during the
27 presentation of the Sheriff’s budget and accordingly, wishes to enact Chapter 140 of the Codified
28 Ordinances, entitled “Reports,” providing the same; and

30 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
31 that it is necessary and in the best interest of the County of Summit to enact Chapter 140 of
32 Codified Ordinances for the reasons set forth above;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
35 of Ohio, that:

37 SECTION 1

39 Section 140 of the Codified Ordinances of the County of Summit, entitled “Reports” is
40 hereby enacted as set forth on Exhibit A, attached hereto and incorporated herein by reference.

42 SECTION 2

44 This Ordinance is hereby declared an emergency in the interest of the health, safety, and
45 welfare of the residents of the County of Summit and for the further purpose of immediately
46 enacting Chapter 140 in order to permit the Sheriff to provide the required reports to Council at
47 the time the Sheriff makes a budget presentation.


