WHEREAS, Lavar Martin filed a complaint against Summit County, concerning alleged unpaid overtime to him and other detention facility employees at the Court of Common Pleas - Juvenile Division, *Lavar Martin v. Summit County*, Case No. 5:19-cv-02641-JRA, before Judge John R. Adams in the United States District Court, Northern District of Ohio (the "Lawsuit"); an

WHEREAS, the Board of Control previously adopted Directive No. 003-20, which awarded a professional service contract with Roetzel & Andress to provide legal representation and services in the Lawsuit, in an amount not to exceed \$50,000.00; and

WHEREAS, this Council previously adopted Resolution No. 2020-137, which authorized the Executive to execute a settlement agreement and release for an amount not to exceed \$167,500.00, to settle any and all claims arising out of or concerning issues raised in the Lawsuit; and

WHEREAS, additional legal representation and services by Roetzel & Andress, LP were necessary to resolve the Lawsuit; and

WHEREAS, the Board of Control, at its October 21, 2020 meeting, awarded Change Order No. 1 to the aforementioned professional service contract with Roetzel & Andress, LPA, in an amount not to exceed \$40,000.00 (for a cumulative increase of 80%), for a total amount of \$90,000.00, subject to confirmation by this Council; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned Change Order No. 1 to said professional service contract with Roetzel & Andress, LPA to provide legal representation and services in the Lawsuit, is necessary and in the best interest of the County of Summit;
