WHEREAS, the County currently has a lease with Xerox/ComDoc for one color copier/printer/scanner that expires in 2021 and a lease with Xerox/ComDoc of one black and white copier/printer/scanner that expires in 2022 both of which are used by the Executive's Department of Finance-Division of Office Services; and

WHEREAS, Xerox/ComDoc has offered to replace the older copiers with one newer, updated printer which would allow the County to produce envelopes and tabs in-house and lower the costs of copies; and

WHEREAS, Xerox/ComDoc proposes to provide a check to the County in the amount of \$87,549.70 to pay the remaining costs under the two current leases and to lease the new copier/printer/scanner at Sourcing Alliance Pricing, for a 60-month term for \$3,855.00 per month, for a cost of \$46,260.00 per year, for a total amount not to exceed \$231,300.00; and

WHEREAS, the Board of Control, at its November 4, 2020 meeting, awarded, subject to the approval of the IT Board, a 60-month lease agreement with Xerox/ComDoc, at Sourcing Alliance Pricing, for one copier/printer/scanner, for a cost of \$3,855.00 per month, for \$46,260.00 per year, for a total amount not to exceed \$231,300.00, subject to confirmation by this Council; and

WHEREAS this Council finds and determines, after reviewing all pertinent information, that the aforementioned lease agreement with Xerox/ComDoc is necessary and in the best interest of the County of Summit;
