7 **A Resolution, pursuant to Section 169.04(h) of the Codified Ordinances of the County of**  
8 **Summit, approving and adopting the Report on Staffing for calendar year 2021, for the**  
9 **Executive, and declaring an emergency.**

11 WHEREAS, Section 169.04(h) of the Codified Ordinances of the County of Summit  
12 requires the Executive to submit annually a report on staffing which sets forth the number of full-  
13 time, part-time and seasonal positions within each job classification, that an office, department,  
14 agency, board or commission may employ during the following calendar year; and

16 WHEREAS, the Report on Staffing submitted by the Executive must be adopted by this  
17 Council no later than December 31<sup>st</sup> of each year; and

19 WHEREAS, the Executive has submitted to this Council a Report on Staffing for  
20 calendar year 2021; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
23 that it is necessary and in the best interest of the County of Summit to adopt the Report on  
24 Staffing for calendar year 2021;

26 NOW, THEREFORE BE IT RESOLVED, by the Council of the County of Summit, State  
27 of Ohio, that:

31 The Report on Staffing for calendar year 2021, which is attached hereto as Exhibit A and  
32 incorporated herein by reference, is hereby approved and adopted by this Council.

36 This Resolution is hereby declared to be an emergency in the interest of the health, safety  
37 and welfare of the residents of the County of Summit and for the further reason that it is  
38 necessary to immediately approve and adopt the Report on Staffing prior to the deadline  
39 established by the Codified Ordinances of the County of Summit.

43 Provided this Resolution receives the affirmative vote of eight members, it shall take  
44 effect immediately upon its adoption and approval by the Executive; otherwise it shall take effect  
45 and be in force at the earliest time provided by law.
