WHEREAS, the Board of Control, at its meeting held October 28, 2020, awarded a professional service contract with Meeder Investment Management, for investment advisory services, for a two-year term, from 1/1/21 through 12/31/22, with two options to renew for an additional two-year term, in an amount not to exceed \$132,000.00; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that the aforementioned professional service contract with Meeder Investment Management is necessary and in the best interest of the County of Summit;
