7 **A Resolution authorizing the Executive to execute any documents necessary to accept the**  
8 **award from the State of Ohio Attorney General's Office of a Federal Fiscal Year 2021**  
9 **Victims of Crime Act grant, in the amount of \$314,430.07 with a 20% local cash match**  
10 **requirement of \$78,607.52, for the Prosecutor, and declaring an emergency.**

12 WHEREAS, the Prosecutor has received an award from the State of Ohio Attorney  
13 General's Office of a Federal Fiscal Year ("FFY") 2021 Victims of Crime Act ("VOCA") grant  
14 in the amount of \$314,430.07, with a 20% local cash match requirement of \$78,607.52, to be  
15 paid from the Prosecutor-General Office General Fund, for the period 10/1/20 through 9/30/21;

18 WHEREAS, the VOCA grant is an annual grant which helps to support salaries and  
19 benefits for seven full-time victim advocates; and

21 WHEREAS, the Prosecutor provides for the required VOCA grant match within her  
22 annual budget; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
25 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
26 execute any documents necessary to accept the aforementioned VOCA grant from the State of  
27 Ohio Attorney General's Office;

29 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
30 of Ohio, that:

34 The Executive is hereby authorized to execute any documents necessary to accept the  
35 award of a Federal Fiscal Year ("FFY") 2021 Victims of Crime Act ("VOCA") grant from the  
36 State of Ohio Attorney General's Office, in the amount of \$314,430.07, with a 20% local cash  
37 match requirement of \$78,607.52, for the period 10/1/19 through 9/30/20.

41 This Resolution is hereby declared an emergency in the interest of the health, safety and  
42 welfare of the residents of the County of Summit and for the further reason to immediately  
43 support necessary victim's advocate services by the Prosecutor's Office.

47 Provided this Resolution receives the affirmative vote of eight members, it shall take  
48 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
49 effect and be in force at the earliest time provided by law.
