11 WHEREAS, the Board of Control, at its November 18, 2020 meeting, awarded contracts
12 for the County's health insurance programs to the providers and for the purposes, terms and
13 amounts to as set forth in Exhibit A, attached to this Resolution and incorporated herein as if
14 fully restated, subject to confirmation by this Council; and

16 WHEREAS, it is necessary to confirm said awards by the Board of Control; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information
19 that it is necessary to confirm the award of said contract for the County's health insurance
20 programs to the providers and for the purposes, terms and amounts to as set forth in Exhibit A;

22 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

27 The award of contracts for the County's health insurance programs to the providers and
28 for the purposes, terms and amounts to as set forth in Exhibit A, attached to this Resolution and
29 incorporated herein as if fully restated, are hereby confirmed and the Executive is hereby
30 authorized to execute said contracts and any necessary related documents.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the residents of the County of Summit and for the further reason to immediately
36 authorize the execution of necessary contracts for health insurance programs for County
37 employees and employees of political subdivisions that have executed a Political Subdivision
38 Participation Agreement with the County.

42 Provided this Resolution receives the affirmative vote of eight members, it shall take
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
44 effect and be in force at the earliest time provided by law.

48 It is found and determined that all formal actions of this Council concerning and relating
49 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
50 deliberations of this Council and of any of its committees that resulted in such formal action,

52 121.22 of the Ohio Revised Code.


