A Resolution authorizing the Executive to apply for and execute Cooperative Agreements with the Ohio Water Development Authority to finance the funding of various sanitary sewer improvement projects being performed countywide, for the Executive's Department of Sanitary Sewer Services, and declaring an emergency.

WHEREAS, the County intends to apply for and execute Cooperative Agreements with the Ohio Water Development Authority ("OWDA") to finance the design of various sanitary sewer improvement projects (the "Projects"), which are set forth in Exhibit A, a copy of which is attached hereto and incorporated herein by reference; and

WHEREAS, the Projects set forth in Exhibit A are included in the Department of Sanitary Sewer Services' Five Year Capital Improvement Plan; and

WHEREAS, OWDA requires the legislative authority of the County to adopt legislation for the application of loans, the execution of agreements, and the designation of dedicated repayment sources; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the Executive to apply for and execute the Cooperative Agreements with OWDA for the aforementioned Projects;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

The Executive is hereby authorized to apply for and execute Cooperative Agreements with the Ohio Water Development Authority ("OWDA") to finance the design of various Sanitary Sewer Improvement Projects (the "Projects") being completed throughout the County, a list of which are set forth in Exhibit A, a copy of which is attached hereto and incorporated herein by reference. A copy of the Cooperative Agreement is attached hereto as Exhibit B and incorporated fully herein, with such modifications and revisions as shall be in furtherance of the provisions of said Cooperative Agreements and not substantially adverse to the County, all of which shall be conclusively evidenced by the execution thereof by the Executive.
