### **SECTION 1**

The Executive is hereby authorized to execute an amendment to a two-year renewal agreement with Oriana House, Inc. and the Summit County Facility Governing Board for the operation of the County of Summit's Community Based Correctional Facility (the "Agreement") for State Fiscal Years 2020-2021, the period 7/1/19 through 6/30/21, to include \$152,224.34 in funds received under the federal Coronavirus Aid, Relief and Economic Security Act ("CARES Act").

# **SECTION 2**

This Council finds and declares that the expenditure of \$152,224.34 under the aforementioned amendment of the Agreement is necessary due to the public health emergency with respect to the COVID-19 pandemic and is being done in compliance with the provisions of Section 5001 of the federal CARES Act.

### **SECTION 3**

This Resolution is declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit and for the further purpose of immediately appropriating CARES grant funds for the operation of the County of Summit's Community Based Correctional Facility in order to be able to properly expend them within the grant period, which ends on 12/31/20.

## **SECTION 4**

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.

### **SECTION 5**

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
