7 **A Resolution confirming an award by the Board of Control of a renewal (fourth and final)**  
8 **of a professional service contract with Oriana House, Inc., for community corrections**  
9 **services, for the period 1/1/16 through 12/31/16, in an amount not to exceed \$5,590,722.28,**  
10 **for the Executive's Department of Law, Insurance and Risk Management – Division of**  
11 **Public Safety, and declaring an emergency.**

13 WHEREAS, County Council previously adopted Resolution No. 2011-501, which  
14 confirmed the award by the Board of Control of a professional service contract to Oriana House,  
15 Inc., for day reporting, driver intervention, home incarceration, multiple offender, pretrial  
16 services and residential community corrections programs, for the period 1/1/12 through  
17 12/31/12, in an amount not to exceed \$5,320,118.46, with four options to renew for an additional  
18 one-year term, with the cost of any renewal term to be equal to the increase in the Consumer  
19 Price Index or three percent, whichever is less; and

21 WHEREAS, Council previously adopted Resolution No. 2013-015, which confirmed the  
22 award by the Board of Control of the renewal (first of four) of a professional service contract  
23 with Oriana House, Inc., for community corrections program services, in an amount not to  
24 exceed \$5,437,436.86; and

25  
26 WHEREAS, Council previously adopted Resolution No. 2014-058, which confirmed the  
27 award by the Board of Control of the renewal (second of four) of a professional service contract  
28 with Oriana House, Inc., for community corrections program services, in an amount not to  
29 exceed \$5,489,832.69; and

31 WHEREAS, Council previously adopted Resolution No. 2015-052, which confirmed the  
32 award by the Board of Control of the renewal (third of four) of a professional service contract  
33 with Oriana House, Inc., for community corrections program services, in an amount not to  
34 exceed \$5,581,202.18; and

35  
36 WHEREAS, the County of Summit wishes to execute a renewal (fourth and final) of a  
37 professional service contract with Oriana House, Inc., for community corrections program  
38 services, for the period 1/1/16 through 12/31/16, in an amount not to exceed \$5,590,722.28; and

40 WHEREAS, the Board of Control, at its meeting on December 16, 2015, approved a  
41 professional service contract to Oriana House, Inc., for community corrections program services,  
42 subject to confirmation by County Council; and

43  
44 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
45 that the renewal (fourth and final) of a community corrections service agreement with Oriana  
46 House, Inc., is necessary and in the best interest of the County of Summit;

48 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

4 SECTION 1

6 The award by the Board of Control of a renewal (fourth and final) of a professional  
7 service contract with Oriana House, Inc., for community corrections services, for the period  
8 1/1/16 through 12/31/16, in an amount not to exceed \$5,590,722.28, is hereby confirmed and the  
9 County Executive is hereby authorized to execute such renewal of said professional service  
10 contract.

12 SECTION 2

14 This Resolution is hereby declared an emergency in the interest of the health, safety and  
15 welfare of the citizens of the County of Summit, and for the further purpose of immediately  
16 providing community corrections services effective 1/1/16.

18 SECTION 3

20 Provided this Resolution receives the affirmative vote of eight members, it shall take  
21 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
22 effect and be in force at the earliest time provided by law.

26 It is found and determined that all formal actions of this Council concerning and relating  
27 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
28 deliberations of this Council and of any of its committees that resulted in such formal action,  
29 were in meetings open to the public, in compliance with all legal requirements, including Section  
30 121.22 of the Ohio Revised Code.
