A Resolution authorizing the County Executive to execute and enter into a sublease agreement to sublease 1,891 square feet of office space on the 2nd floor of 1180 S. Main St., Akron, Ohio 44311 to the Summit County Land Reutilization Corporation, aka Summit County Land Bank, for the Executive's Department of Law, Insurance and Risk Management, and declaring an emergency.

WHEREAS, the County is the lessee of certain real property located at 1180 S. Main St., Akron, Ohio 44311 ("Property"), in Council District 4, pursuant to a certain lease agreements ("Leases") dated November 25, 2014 with Akron Phoenix Development Company; and

WHEREAS, pursuant to Section 7.3 of the Leases, the County is permitted to sublet any portion of the Property to governmental and non-profit entities; and

WHEREAS, the County Executive desires to sublease 1,891 square feet of office space on the 2nd floor of the Property to the Summit County Land Reutilization Corporation, aka Summit County Land Bank, for its general operations, for a period of five years, from March 1, 2016 to February 28, 2021, for an amount not to exceed \$204,042.20 during the term of the sublease, with one option to renew for an additional five year term; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County to authorize the County Executive to execute and enter into the aforementioned sublease agreement.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The County Executive is hereby authorized to execute and enter into a sublease agreement to sublease 1,891 square feet of office space on the 2nd floor of 1180 S. Main St., Akron, Ohio 44311, in Council District 4, to the Summit County Land Reutilization Corporation, aka Summit County Land Bank, for its general operations, for a period of five years, from March 1, 2016 to February 28, 2021, for an amount not to exceed \$204,042.20 during the term of the sublease, with one option to renew for an additional five year term. A copy of the lease is attached hereto and incorporated herein by reference as Exhibit A.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit and for the further reason of immediately approving the aforementioned sublease agreement so that the same may be executed by the parties prior to the commencement of the term of the sublease.
