8 **accept a 2016 Statewide Search and Rescue Grant from the Ohio Emergency Management**

10 **match requirement, and appropriating these grant funds, for the Executive's Department**
11 **of Law, Insurance and Risk Management – Division of Public Safety/Emergency**
12 **Management Agency, and declaring an emergency.**

14 WHEREAS, the Ohio Emergency Management Agency has granted a 2016 Statewide
15 Search and Rescue Grant to the Summit County Emergency Management Agency for the period
16 7/1/15 through 6/30/16, in the amount of \$6,250.00, with no local cash match requirement; and

18 WHEREAS, the purpose of the grant is to help sustain Region 5's collapse search and
19 rescue capabilities through the purchase of equipment, expendable materials and supplies; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
22 that it is necessary and in the best interest of the County of Summit to authorize the County
23 Executive to execute any documents necessary to accept the award of the aforementioned grant
24 and to appropriate these grant funds;


