7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept a 2016 Statewide Search and Rescue Water grant from the Ohio Emergency**  
9 **Management Agency, for the period 7/1/15 through 6/30/16, in the amount of \$5,000.00,**  
10 **with no local cash match requirement, and appropriating funds, for the Executive's**  
11 **Department of Law, Insurance and Risk Management – Division of Public Safety/**  
12 **Emergency Management Agency, and declaring an emergency.**

14 WHEREAS, the Ohio Emergency Management Agency has awarded a 2016 Statewide  
15 Search and Rescue – Water Grant from the State Homeland Security Program to the Summit  
16 County Emergency Management Agency for the period 7/1/15 through 6/30/16, in the amount of  
17 \$5,000.00, with no local cash match requirement; and

19 WHEREAS, the purpose of the grant is to help sustain Region 5's water rescue  
20 capabilities through the purchase of equipment, expendable materials and supplies; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
23 that it is necessary and in the best interest of the County of Summit to authorize the County  
24 Executive to execute any documents necessary to accept the award of the aforementioned grant  
25 and to appropriate these grant funds;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

32 The County Executive is hereby authorized to execute any documents necessary to accept  
33 the 2016 Statewide Search and Rescue - Water Grant from the Ohio Emergency Management

35 match requirement.

14 2016 Search and Rescue Grant and to appropriate and expend the funds within the grant period.

18 Provided this Resolution receives the affirmative vote of eight members, it shall take  
19 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
20 effect and be in force at the earliest time provided by law.
